

Registration Information 2020/2021



Registration Fee

A non-refundable *Registration Fee* is due upon registration for full year classes.

The *Registration Fee* is \$30.00 for the first child in the family and \$10.00 for any additional child.

Payment of the *Registration Fee* is required at time of registration to ensure placement.

La Pointe Dance Studio will not reserve a space in class for any student until the *Registration Fee* is received.

Tuition

Payment for the full tuition is required before the start of classes

- The tuition for the full year program (September through June) can be made in one of 3 ways:
 1. One lump sum payment in cash or cheque dated no later than September 1st.
 2. Three post dated cheques. One dated September 1st (for Sep-Dec tuition), one dated January 1st (for Jan-Mar tuition) and one dated April 1st (for Apr-Jun tuition)
 3. Sign for Pre-Authorized Deposit (PAD) Plan

The monthly payments are calculated so that tuition fees are paid in equal monthly instalments and do not change regardless of the number of classes in each month.

There are no refunds for any missed classes.

Full year program:

- The tuition fees include between 33 and 36 classes per year depending on the day of the week when the class takes place (Please refer to our calendar of events for a list of holidays)
- The tuition fee does not include the fees for exams, participation on the performing group, participation in the year-end show or any other special event.

Payment

Tuition payments can be made in cash, using e-transfer, in cheque payable to La Pointe Dance Studio or through a Pre-Authorized Deposit (PAD) Plan.

There is a \$25 charge for each Non-Sufficient-Funds (NSF) payment. NSF must be honoured within 10 days in cash or using e-transfer.

Withdrawal policy

Full year program: Written notice of withdrawal must be received at least one (1) month in advance. Outstanding post-dated cheques after the one (1) month period will be returned or the corresponding pre-paid tuition amount will be refunded. No refunds will be issued after April 1st, 2020 (last day for withdrawal notice is Feb 28, 2021)

Season program: Full refund will be given only if written notice of withdrawal is provided to La Pointe Dance Studio at least five (5) days prior to the starting date. There are no refunds for the season programs starting 5 days before the first class of the session.

General policies

- La Pointe Dance Studio reserves the right to reschedule, cancel or combine any classes due to low registration. If all classes for a particular student are cancelled, the registration fee will be refunded.
- To ensure the health and safety of our students and faculty, La Pointe Dance Studio reserves the right to move classes to a virtual platform in the event of a global pandemic such as COVID-19 without adjusting or refunding tuition.
- Students are responsible for any damage they may cause to the studio.
- If the Pre-Authorized Deposit (PAD) Plan is terminated, tuition payments must be replaced with cash e-transfer or cheque. The ability to terminate the PAD does not override the withdrawal policy above.
